As discussed please see pros and cons below re trespass notices for both DHSEF

General observations:

A trespass notice is a good tool to put someone on notice outlining the rules and also to enable police a mechanism to put someone before the court if a breech is committed. If no trespass notice is in effect then a warning process has to be endured before an offence of trespass is committed. Therefore in a situation where you require police attendance immediately and where something can be done even once the person committing the trespass has left it is better to have a trespass order already served on a person and in existence.

Having said that the following are considerations towards both subjects outlining the pros and cons of servicing a trespass notice prior to the APM is outlined below:

Subject 1:

This subject has been previously trespassed from SRES building.

This trespass period of two years has expired meaning that this person is no longer subject to an effective trespass notice.

This person has in the past two years not attempted to approach SRES nor breached the trespass notice.

This person has been denied an insurance claim and therefore has no legitimate reason to approach SRES.

Serving a fresh trespass notice may reignite the for this individual.

This person being allowed access to the SRES APM is not considered appropriate as he still poses a threat based upon his previous comments.

If this person presents himself at SRES pending APM he can and should be refused entry by security personnel in attendance who will have trespass authority for the venue on the day.

Similarly if this person presents himself at SRES office he can and should be refused entry at the time and if and when this occurs consideration can be given to serving a fresh trespass notice on him.

In my opinion I do not believe that re issuing a trespass notice on - RELEAUA would be constructive at this time and doing so may inflame the situation.

Subject 2:

This subject has not previously been trespassed from SRES however his behaviour is of concern and to trespass him is justified.

This subject has been dis-communicated from the SRES board after harassing them with an extraordinary number of emails, these emails still continue however are blocked by the SRES server and dealt with at an operational level.

This email harassment resulted in SRES taking particular security measures and notifying police resulting in police visiting to assess his propensity towards being a threat to SRES and its personnel.

The subject is vexatious and has engaged multiple courses of legal recourse such as the Ombudsman and Privacy officer to name a few and his behaviour suggests that this person be treated with caution.

This subject has in the past RSVP'ed to attend the APM but in the past two years has not attended.

Serving a trespass notice on this individual prior to the APM may provoke him and result in a heightened level of activity and result in behaviour that could be considered threatening.

• Based upon this persons previous correspondence and that the communication has deteriorated to be managed through legal channels and litigious methods there is no value that can be achieved by this person attending the SRES APM.

• If this person presents himself at SRES pending APM he can and should be refused entry by security personnel in attendance who will have trespass authority for the venue on the day.

• Similarly if this person presents himself at SRES office he can and should be refused entry at the time and if and when this occurs consideration can be given to serving a fresh trespass notice on him.

In summary I don't think that either of these persons should be served with new trespass notices prior to the APM however they should not be allowed entry to the APM and that this should be enforced, security personnel will have trespass authority for that venue. If either of the two present themselves at the APM they should be refused entry for the event centre and at the same time a current trespass notice covering SRES venues can be served. These trespass notices should be prepared prior to the APM and dated 7 October and signed by the new CEO, they may not be used if either of the subjects do not attempt to attend the APM. If they are not used they will be destroyed and SRES notified.

The grounds for not allowing Mr will be cited as his previous threats towards SRES staff are considered still valid and **sector** as continued email harassment and vexatious complaints and that due to the litigious and perceived hostile nature of **sector** SRES do not believe that his attendance at the meeting would be productive and that proper dialogue could not be established.

It is likely that refusing entry of individuals may provoke the need for security personnel to use reasonable force to prevent access and that police would be immediately notified in the event of attempted attendance by either subject.

O trust that this assists SRES in making a determination and I am happy to discuss my opinion in more detail if there is any clarity required.




